A UNIQUE OPPORTUNITY:

The National Curriculum Manager is responsible for overseeing ASAS's youth program academies, content development platforms, and our signature annual youth conference (All-Star Leadership University). This position requires a skilled and experienced youth development professional who works as part of the Programs Division to develop and deliver high-quality youth programs and content responsive to the needs of our chapters, staff, and youth.

SPECIFIC RESPONSIBILITIES:

Curriculum Development -

- Identify, design, and disseminate new content and curriculum based on programmatic and development priorities across the network.
- Expand the ASAS content library and ensure resources meet the developmental and cognitive needs of youth in the form of grade-specific, scaffolded content and rigor.
- Leverage the ASAS community of practitioners, site leads, instructional coaches, and other chapter-level staff to continuously improve teaching and learning resources.
- Show a strong command of national education and youth development trends, regularly benchmarking the initiatives of peer organizations to ensure that all programs and initiatives are industry-leading for the youth development sector.

WHO SHOULD APPLY?

The National Curriculum Manager should embody ASAS's core values: accountable, collaborative, transparent, proactive, and entrepreneurial. The National Curriculum Manager is a national leadership position and is expected to have at least 6-8 years' experience in the youth development or education sector with demonstrated success in programs, professional development, evaluation, and content facilitation.

The ideal candidate will also possess excellent interpersonal and stewardship skills with the ability to passionately communicate ASAS's mission and accomplishments. An understanding of the national non-profit, education landscape, and a successful track record within the youth development sector. Excellent communication and relationship-building skills with an ability to prioritize, negotiate, and work with a variety of internal and external stakeholders. An undergraduate degree is required. Although the position is remote, ideally, you would be in LA, DC, or in one of our chapter states
