## **EVENT TERMS & CONDITIONS**

### **SECURITY IDENTIFICATION**

All guests are required to provide the full names and contact details for themselves and their guests. Attendees will provide a clear headshot/photograph (without sunglasses, hats, or other obscuring accessories) to the ASAS Parties in order to ensure proper identification by security staff upon arrival at the event. No guests will be admitted without a paid ticket or otherwise pre-agreed upon arrangement. No exceptions.

### **SOCIAL MEDIA POLICY**

Safety precautions will be enacted in accordance with the evolving COVID-19 and other contagious diseases health situation in Los Angeles County at the time of the event. All guests will need to receive a negative test result in order to enter the event. ASAS will provide rapid antigen tests by mail to all guests and will arrange for a virtual proctor service to oversee the test administration. Should a positive result be received, the guest(s) will not be admitted into the event.

Your results will only be shared with the affiliated parties producing the event including After-School All-Stars, Oak Productions, Westtime and The Baker Group in order for them to make informed health and safety decisions pertaining to the event. This information will not be shared for any other purpose than stated above. Other precautions before and during the event may include: temperature checks, mask wearing and/or other measures as dictated by current guidance. We will proactively communicate the health and safety measures that will be in place closer to the event date but please do not hesitate to reach out with questions. Failure to comply with these measures before and at the event itself will result in dismissal from the event without possibility of a refund.
